- Market consumption volume increased with a CAGR of 1.5% between 2017 and 2022, to reach a total of 6,681.2 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 5% for the five-year period 2022 2027, which is expected to drive the market to a value of \$69,401.0 million by the end of 2027.
