Foodservice is restricted to the sales of food and drink in specific foodservice channels defined below and excludes vending machines.
- The US foodservice industry had total revenues of \$992.1 billion in 2022, representing a compound annual growth rate (CAGR) of 2.7% between 2017 and 2022.
- Industry consumption volume increased with a CAGR of 0.9% between 2017 and 2022, to reach a total of 98.3 billion transactions in 2022.
- The US foodservice industry is the largest single country globally, accounting for 28.3% of the global industry's total value in 2022.
