- The Brazilian Meat market had total revenues of \$41,441.9 million in 2022, representing a compound annual growth rate (CAGR) of 6.4% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.2% between 2017 and 2022, to reach a total of 8,337.3 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.9% for the five-year period 2022 2027, which is expected to drive the market to a value of \$47,746.7 million by the end of 2027.
