- The Brazilian hybrid & electric cars market had total revenues of \$1,074.9 million in 2022, representing a compound annual growth rate (CAGR) of 59.3% between 2017 and 2022.
- Market production volume increased with a CAGR of 52.5% between 2017 and 2022, to reach a total of 39,656.0 units in 2022.
- The growth in the Brazilian hybrid & electric cars market is influenced by several macroeconomic factors, such as rising GDP, growing consumer confidence, and an increase in disposable income among individuals. For instance, according to the Instituto Brasileiro de Economia, the FGV-IBRE Consumer Confidence Index in Brazil increased by 2 points to 96.8 in August 2023, surpassing market estimates of 93.3.
