All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The Japanese Meat market had total revenues of \$31,390.5 million in 2022, representing a compound annual growth rate (CAGR) of 2.3% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1% between 2017 and 2022, to reach a total of 1,981.6 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 1.7% for the five-year period 2022 2027, which is expected to drive the market to a value of \$34,199.4 million by the end of 2027.
