- Industry consumption volume increased with a CAGR of 0.1% between 2017 and 2022, to reach a total of 19,418 establishments in 2022.
- Thailand accounted for a share of 13.1% in the Asia-Pacific hotels & motels industry in 2022. The demand for hotels & motels in the country is attributed to the growing travel & tourism industry, the growing middle-class population, rising consumer purchasing power and expenditure, and economic growth.
