- According to in-house research, in 2022, the Australian apparel retail industry witnessed an annual growth of 24.3%. According to the Australian Bureau of Statistics, in May 2023, clothing, footwear, and personal accessory retailing grew by 3.9% (seasonally adjusted) over May 2022.
