- The Polish hotels & motels industry had total revenues of \$3.5 billion in 2022, representing a negative compound annual growth rate (CAGR) of 3.7% between 2017 and 2022.
- Industry consumption volume increased with a CAGR of 0.4% between 2017 and 2022, to reach a total of 2,593 establishments in 2022.
- The Polish accounted for a small share of 1.3% of the European hotels & motels industry in 2022. The demand for hotels & motels in the country is attributed to the growing travel & tourism industry, the growing population, growing business travel, rising consumer purchasing power and expenditure, and economic growth.
