Foodservice is restricted to the sales of food and drink in specific foodservice channels defined below and excludes vending machines.

- The Russian foodservice industry had total revenues of \$11.7 billion in 2022, representing a negative compound annual growth rate (CAGR) of 2.3% between 2017 and 2022.

- Industry consumption volumes declined with a negative CAGR of 4.1% between 2017 and 2022, to reach a total of 2.3 billion transactions in 2022.

- Russian foodservice industry revenues accounted for just 1.6% of the total European foodservice industry in 2022.
