In the case of motels, this includes off-street parking facilities, but not necessarily meal services. The industry is detailed in both value and volume terms.
- The Finnish hotels & motels industry had total revenues of \$1.1 billion in 2022, representing a negative compound annual growth rate (CAGR) of 9.9% between 2017 and 2022.
- Industry consumption volumes declined with a CAGR of 0.2% between 2017 and 2022, to reach a total of 616 establishments in 2022.
- Finland accounted for a small share of 0.4% of the European hotels & motels industry in 2022. The demand for hotels & motels in the country is attributed to the growing travel & tourism industry, the growing population, rising consumer purchasing power and expenditure, and economic growth.
