Foodservice is restricted to the sales of food and drink in specific foodservice channels defined below and excludes vending machines.
- The German foodservice industry had total revenues of \$79.7 billion in 2022, representing a negative compound annual growth rate (CAGR) of 3.3% between 2017 and 2022.
- Industry consumption volumes declined with a negative CAGR of 4.1% between 2017 and 2022, to reach a total of 8.3 billion transactions in 2022.
- Germany captured a share of 10.9% of the European foodservice industry's value in 2022.
