All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The German Prepared Meals market had total revenues of \$5,212.7 million in 2022, representing a compound annual growth rate (CAGR) of 4.5% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.5% between 2017 and 2022, to reach a total of 970.2 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.2% for the five-year period 2022 2027, which is expected to drive the market to a value of \$5,821.4 million by the end of 2027.
