- Industry consumption volume increased with a CAGR of 0.9% between 2017 and 2022, to reach a total of 10,218 establishments in 2022.
- Greece accounted for a share of 8.9% of the European hotels & motels industry in 2022. The demand for hotels & motels in the country is attributed to the growing travel & tourism industry, the growing population, rising consumer purchasing power and expenditure, and economic growth.
