- Childrenswear includes all clothing designed for children between the ages of 0-15, such as baby clothing, boys' casualwear, boys' school wear, boys' underwear (vests, underpants, socks) and nightwear, boys' formalwear-occasion, boys' outerwear including regional or national attire, girls' casualwear, girls' school wear, girls' underwear (knickers, bras, vests, socks, and tights) and nightwear, girls' formalwear-occasion, girls' outerwear including regional and national attire, such as saris, and toddler clothing. It also includes all sportswear and fancy dress.
- The Dutch apparel retail industry had total revenues of \$17.3 billion in 2022, representing a compound annual growth rate (CAGR) of 3.9% between 2017 and 2022.
- The womenswear segment accounted for the industry's largest proportion in 2022, with total revenues of \$9.4 billion, equivalent to 54.3% of the industry's overall value.
- The growth in the Dutch apparel retail industry is influenced by several macroeconomic factors, such as rising GDP and growing consumer confidence. For instance, according to Statistics Netherlands, the Netherlands' consumer confidence indicator rose to -39 in September 2023 from a six-month low of -40 but remains below the average over the past twenty years of -10.
