It also includes all sportswear and fancy dress.
- The Portuguese apparel retail industry had total revenues of \$6.6 billion in 2022, representing a compound annual growth rate (CAGR) of 2.3% between 2017 and 2022.
- The womenswear segment accounted for the industry's largest proportion in 2022, with total revenues of \$4.0 billion, equivalent to 60.8% of the industry's overall value.
- The growth in the Portuguese apparel retail industry is influenced by several macroeconomic factors, such as rising GDP and growing consumer confidence. For instance, according to Statistics Portugal, Portugal's consumer confidence index rose for the eighth consecutive month to -21.9 in August 2023, reaching its highest level since February 2021.
