- The Spanish hybrid & electric cars market had total revenues of \$12.8 billion in 2022, representing a compound annual growth rate (CAGR) of 34.7% between 2017 and 2022.
- Market production volume increased with a CAGR of 33.1% between 2017 and 2022, to reach a total of 224,864.0 units in 2022.
- The growth in the Spanish hybrid & electric cars market is influenced by several macroeconomic factors, such as rising GDP, growing consumer confidence, and an increase in disposable income among individuals. For instance, according to the Centro de Investigaciones Sociológicas, in June 2023, Spain's consumer confidence index reached its highest level since October 2021, rising from 73 to 92.4.
