- The UK accounted for significant share of 13.0% in the European hotels & motels industry in 2022. The demand for hotels & motels in the country is attributed to the growing travel & tourism industry, the growing population, rising consumer purchasing power and expenditure, rising medical tourism, and economic growth.
