Foodservice is restricted to the sales of food and drink in specific foodservice channels defined below and excludes vending machines.
- The UK foodservice industry had total revenues of \$83.7 billion in 2022, representing a negative compound annual growth rate (CAGR) of 1.4% between 2017 and 2022.
- Industry consumption volumes declined with a negative CAGR of 1.8% between 2017 and 2022, to reach a total of 8.4 billion transactions in 2022.
- The UK captured a share of 11.5% of the European foodservice industry in 2022.
