- Market consumption volume increased with a CAGR of 0.6% between 2017 and 2022, to reach a total of 2,513.8 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.9% for the five-year period 2022 2027, which is expected to drive the market to a value of \$29,276.0 million by the end of 2027.
