- The UK Prepared Meals market had total revenues of \$7,303.9 million in 2022, representing a compound annual growth rate (CAGR) of 4.9% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.1% between 2017 and 2022, to reach a total of 830.4 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.6% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$8,310.0 million by the end of 2027.
