- The Israeli hotels & motels industry had total revenues of \$4.1 billion in 2022, representing a negative compound annual growth rate (CAGR) of 1.1% between 2017 and 2022.
- Industry consumption volume increased with a CAGR of 1.5% between 2017 and 2022, to reach a total of 438.0 establishments in 2022.
- According to in-house research, in 2022, the Israeli hotels and motels industry witnessed an annual growth of 62.9% due to the increase in the number of tourists. According to the Israel Ministry of Tourism, in 2022, Israel received 2.7 million tourists (excluding day visitors and cruise passengers).
