- The womenswear segment accounted for the industry's largest proportion in 2022, with total revenues of \$2.3 billion, equivalent to 43.1% of the industry's overall value.
- Israel's headline inflation is higher than the target range, and higher prices can cause consumers to spend less on apparel. These factors resulted in the slow growth in 2022.
