All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The Turkish Meat market had total revenues of \$6,540.4 million in 2022, representing a compound annual growth rate (CAGR) of 28.4% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.3% between 2017 and 2022, to reach a total of 719 million kilogram in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 23.6% for the five-year period 2022 2027, which is expected to drive the market to a value of \$18,858.2 million by the end of 2027.
