- The Turkish hybrid & electric cars market had total revenues of \$1,673.7 million in 2022, representing a compound annual growth rate (CAGR) of 77.1% between 2017 and 2022.
- Market production volume increased with a CAGR of 55.3% between 2017 and 2022, to reach a total of 29,910.0 units in 2022.
- The growth in the European hybrid & electric cars market is influenced by several macroeconomic factors, such as rising GDP, growing consumer confidence, and an increase in disposable income among individuals. For instance, according to the Turkish Statistical Institute, in May 2023, the consumer confidence index in Turkey stood at 91.06, up from 80.1 in March 2023.
