- The North American Prepared Meals market had total revenues of \$52,151.8 million in 2022, representing a compound annual growth rate (CAGR) of 5.5% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 3.7% between 2017 and 2022, to reach a total of 5,831.4 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.7% for the five-year period 2022 2027, which is expected to drive the market to a value of \$59,630.9 million by the end of 2027.
