- Industry consumption volume increased with a CAGR of 1.3% between 2017 and 2022, to reach a total of 5,333 establishments in 2022.
- In the Middle East, the UAE is the largest industry, accounting for 47.3% share of the industry, followed by Saudi Arabia (29.7%), Israel (14.3%), and Egypt (9.8%).
