- Scandinavia accounted for 0.62% of the global jewelry & watches market. In Scandinavia, Sweden is the largest market accounting for 36.31% of the Scandinavian market followed by Norway (26.03%), Denmark (23.62%), and Finland (14.04%) in 2022.
