The soups industry within the NAFTA countries had a total market value of \$9,281.8 million in 2022. The US was the fastest growing country, with a CAGR of 7.6% over the 2018-22 period.
- Within the soups industry, the US is the leading country among the NAFTA bloc, with market revenues of \$8,255.3 million in 2022. This was followed by Canada and Mexico, with a value of \$815.2 and \$211.3 million, respectively.
- The US is expected to lead the soups industry in the NAFTA bloc, with a value of \$9,231.2 million in 2027, followed by Canada and Mexico with expected values of \$988.1 and \$288.3 million, respectively.
