- The global Beer & Cider market had total revenues of \$621,827.2 million in 2022, representing a compound annual growth rate (CAGR) of 2.9% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.1% between 2017 and 2022, to reach a total of 180,217.6 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 7.0% for the five-year period 2022 2027, which is expected to drive the market to a value of \$872,836.0 million by the end of 2027.
