- Within the fish & seafood industry, China is the leading country among the top 5 emerging nations, with market revenues of \$50,775.7 million in 2022. This was followed by Brazil and Mexico with a value of \$7,379.0 and \$3,834.5 million, respectively.
- China is expected to lead the fish & seafood industry in the top five emerging nations, with a value of \$84,086.4 million in 2027, followed by Brazil and Mexico with expected values of \$10,197.0 and \$5,799.7 million, respectively.
