- Within the apparel retail industry, China is the leading country among the BRIC nations with market revenues of \$273,658.2 million in 2022. This was followed by India, Russia and Brazil with a value of \$59,980.5, \$35,767.2, and \$26,350.8 million, respectively.
- China is expected to lead the apparel retail industry in the BRIC nations with a value of \$394,299.8 million in 2027, followed by India, Russia, Brazil with expected values of \$89,219.4, \$35,919.8 and \$33,152.6 million, respectively.
