- Among the G8 nations, the US is the leading country in the food & grocery retail industry, with market revenues of \$1,658,026.1 million in 2022. This was followed by Japan and Germany, with a value of \$413,516.4 and \$307,075.3 million, respectively.
- The US is expected to lead the food & grocery retail industry in the G8 nations with a value of \$1,907,536.4 million in 2016, followed by Japan and Germany with expected values of \$478,107.0 and \$370,830.2 million, respectively.
