The Canada was the fastest growing country, with a CAGR of 2.6% over the 2018-22 period.
- Within the containers & packaging industry, the US is the leading country among the NAFTA bloc, with market revenues of \$130.7 billion in 2022. This was followed by Mexico and Canada, with a value of \$27.3 and \$14.4 billion, respectively.
- The US is expected to lead the containers & packaging industry in the NAFTA bloc, with a value of \$139.2 billion in 2027, followed by Mexico and Canada with expected values of \$31.4 and \$16.4 billion, respectively.
