- Within the containers & packaging industry, China is the leading country among the BRIC nations with market revenues of \$77.9 billion in 2022. This was followed by Russia, Brazil and India with a value of \$28.6, \$22.3, and \$17.7 billion, respectively.
- China is expected to lead the containers & packaging industry in the BRIC nations with a value of \$89.9 billion in 2027, followed by Russia, Brazil, India with expected values of \$27.5, \$26.8 and \$22.5 billion, respectively.
