- Within the sports equipment retail industry, China is the leading country among the BRIC nations with market revenues of \$28,727.5 million in 2022. This was followed by Russia, India and Brazil with a value of \$4,255.4, \$3,679.4, and \$3,120.5 million, respectively.
- China is expected to lead the sports equipment retail industry in the BRIC nations with a value of \$39,268.2 million in 2027, followed by India, Russia, Brazil with expected values of \$6,647.3, \$4,097.4 and \$3,655.9 million, respectively.
