Compared to other areas of apparel and footwear, childrenswear saw relatively modest growth in current value terms in 2023. Sales of childrenswear were comparatively unaffected by the pandemic, as despite the lockdown, parents still needed to purchase new childrenswear to replace existing, outgrown clothing. Consequently, despite the easing of pandemic-related restrictions, including the reopening of shopping malls, there was no dramatic rebound in sales in 2022 and 2023.
