Inflationary pressure began to surge in 2022 following the start of the war in Ukraine. Consumer confidence remains curbed in 2023, with some consumers limiting shopping expenses and choosing to save money given the economic downturn. As a result, retail volume sales of womenswear have witnessed further decline in 2023.
