Charge cards were not issued by banks in Turkey at the end of the review period. Instead, credit cards and debit cards remain the two main types of financial card. Consumers who use credit cards employ them mostly for the "pay later" function, while they use debit cards, which do not have a "pay later" function, for micropayments. Over the forecast period, banks may launch products with charge card functions to diversify their card portfolios.
