To secure an adequate domestic supply of edible oils and keep prices for consumers at affordable levels, early in 2023 the Argentinian government renewed its subsidy agreement with members of industry representative group CIARA (Chamber of the Oil Industry of the Argentine Republic). In the latest iteration of this deal, which was initially signed in 2021 and extended in 2022, participating companies have created a fund of USD120 million to finance the supply of 29 million litres of edible oils...
