Unit prices of edible oils continued to fluctuate in 2023. While sunflower oil's unit price saw jumps due to the war in Ukraine, olive oil also became more expensive due to the effect of drought on supply. Overall, at the end of the review period, edible oil consumption continued to see normalisation after the channel shifts seen during the COVID-19 pandemic when foodservice sales plummeted and retail sales soared as consumers cooked and baked more food at home. Preparing food at home continues...
