After very positive retail volume growth was recorded in the category during the early stages of the COVID-19 pandemic in 2020, growth was stagnant in 2021 before a long-term decline was seen during 2022 and 2023, which can be seen as the flip side of the significant uplift in retail sales that occurred at...
