Part of this decline is due to the widespread availability of smuggled soup in outdoor markets. Smuggling has increased significantly in recent years. Bolivia's fixed exchange rate, coupled with recent sharp devaluation of its neighbours' currencies, makes Bolivia a highly profitable market for smuggling.
