In December 2022, Osem announced a price rise for many of its products, including pasta, of 5.9%. Six months later, Osem announced another price hike for its pasta, of 4.5%, that went into effect in June 2023. In May 2023, Shestowitz increased the price of Barilla pasta by 10%, which came after a 12% price increase in early 2022. Shestowitz tried increasing prices again in mid-2022, but the government prevented it from doing so. In October 2022, Sugat announced a price increase of 15% for its ri...
