Rice prices have been on somewhat of a rollercoaster. While many agricultural commodities have shown signs of stabilisation, the supply of rice was hit hard in 2023 by India's export ban on rice. With India looking to ensure it has enough rice to meet domestic demand and to control domestic prices it introduced a ban on the export of non-basmati white rice in July 2023, effectively halving its rice exports. This followed heavy monsoon rains which destroyed large crops. This move followed the ban...
