With the war in Ukraine still having an inflationary impact on wheat prices, and with bread being one of the most important staple for Bolivians, the government subsidised the price of flour for bakers. Government authorities reported that 2 million quintals of flour were distributed in 2023 to bakers, through the Food Production Support Company (EMAPA), thus guaranteeing the stability of the price of unpackaged bread at BOB 0.50 cents per unit.
