Baked goods is expected to register double-digit current value growth in 2023, though volume growth is expected to be much more moderate, as inflation still remains an issue. Though there was a decrease in the price of flour, as supplies from Russia increased and with the Russian rouble also depreciated, these prices did not feed into lower prices for baked goods. Continuing population growth is expected to support a moderate volume increase.
