Retail sales of breakfast cereals in Malaysia recorded continued growth in volume terms in 2023. This was in spite of the weakening of the local currency, the ringgit, against the US dollar, which brought about higher import costs. With Malaysia importing most of its breakfast cereals, consumers had to pay a higher price for such products. Nestle (M) Bhd, for example, increased the prices of all its breakfast cereals in September 2023, reflecting higher costs for sugar, cocoa and grains.
