Despite the initial launch of new brands like Nescafe Cold Brew in early 2020, accompanied by extensive marketing efforts, pandemic-related restrictions stymied the category's expansion. Nescafe Cold Brew later exited the Peruvian market, leaving Starbucks (North American Coffee Partnership) and Cafe Ole (The Braedt SA) as the primary brands in volume sales terms in 20...
