Sweet spreads is set to see slight growth in retail current value terms in Japan in 2023. However, this growth is mainly due to price increases for sweet spreads, and retail volume sales are expected to see another year of decline, primarily due to the continued backlash from the high sales recorded during the COVID-19 pandemic in 2020. However, retail volume sales are anticipated to remain above the pre-pandemic level.
