All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The South African Wine market had total revenues of \$971.8 million in 2022, representing a negative compound annual growth rate (CAGR) of 2.1% between 2017 and 2022.
- Market consumption volumes declined with a negative CAGR of 0.5% between 2017 and 2022, to reach a total of 377.2 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.8% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$1,285.6 million by the end of 2027.
